Please go to the MD-4 website: <http://www.md4lions.org> and complete the affidavit form, submit online, mail or email the enclosed form to the MD-4 office as soon as your club appoints the delegates. Keep a copy for the club records.

(A chartered club in good standing is defined as a club, which is current with the payment of its per capita tax to Lions Clubs International and to Multiple District Four.)

1. The membership reported to Lions Clubs International on the **December 31, 2016 MMR (This date is not a mistake; one year and one day prior to the month preceding the convention)** form will be used by LCI and forwarded to your Governor to verify the number of delegates. Use the **December 2016** membership number in the space provided and base the number of voting delegates as follows: ONE (1) delegate for each TEN (10) members or major fraction thereof (5 or more).
2. **DO NOT LIST A DISTRICT GOVERNOR OR A PAST DISTRICT GOVERNOR AS A DELEGATE.** They have an automatic vote in addition to the club's allowable number of delegates.
3. 1st or 2nd Vice District Governor **MUST** be listed as a delegate in order to vote.
4. **NEW CLUBS chartered after December 31, 2016 are eligible for one delegate and one alternate only.**

MD4con:

1. Delegates attending the 99TH annual MD-4 Convention in San Diego should report to the certification area to receive a delegate credential.
2. Delegates must be registered for the convention.
3. The credential certification will be open:
 - Friday, Feb. 9, from 9:00 a.m. to 5:00 p.m. (closed during meals)
 - Saturday, Feb. 10, from 9:00 a.m. to 5:00 p.m. (closed during meals)
 - Sunday, Feb. 11 from 7:00 a.m. to 9:45 a.m.

REMEMBER – CLUBS MUST BE IN GOOD STANDING WITH ALL DUES TO LCI AND MD4/DISTRICT PAID THROUGH DECEMBER 2017 OR DELEGATES CANNOT BE CERTIFIED TO VOTE.

****NOTE: All Dues over 30 days owed to LCI, MD4 and respective Districts must be paid by January 25, 2018 (15 days prior to the event).***

THE CLUBS OF THE COUNCIL OF GOVERNOR MEMBERS, PAST DISTRICT GOVERNORS, AND PAST INTERNATIONAL OFFICERS MUST BE IN GOOD STANDING TO VOTE.

VOTING: SUNDAY, FEBRUARY 11, 2018 FROM 7:00 to 10:00 a.m.
